Terms and Conditions for Vector's Monthly Prize Draw

Every electricity or gas connection application completed online will go into a prize draw to win one double pass to an event at Vector Arena in Auckland. There will be 6 prize draws – one each month on the last day of the month from November 2016 to April 2017 (each a "Monthly Prize Draw"). By submitting an online electricity or gas connection application, the entrant:

- is deemed to have read and accepted the following terms and conditions of entry;
- confirms that the entrant has the necessary authority to enter the Monthly Prize Draw.
 - 1. To be eligible to win a Monthly Prize Draw, the application must be completed and submitted in accordance with these terms and conditions.
 - 2. To be eligible to win a Monthly Prize Draw, you must be over 18 years of age.
 - 3. Every connection application correctly completed online during a month from November 2016 to April 2017 will go in the Monthly Prize Draw for that month, so multiple online applications for different electricity and gas connections during a month, or during different months between November 2016 and April 2017 means multiple chances to win.
 - 4. Entries for a Monthly Prize Draw close at midnight on the last day of each month. Applications made after this time will go into the Monthly Prize Draw for the next month until April 2017.
 - 5. The prize is two complimentary tickets to an event of the winner's choosing (subject to availability as set out in paragraph 6) at Vector Arena in Auckland, which is scheduled to take place before 30 September 2017 (the "**Prize**"). There are a total of 6 Prizes to be won. Each entry is only eligible to win one Prize.
 - 6. Tickets are subject to availability of complimentary tickets for the winner's chosen event. At the time Vector notifies each of the 6 winners, each winner will be asked which event he or she wishes to attend. Vector will then check availability and if two complimentary tickets are not available for a winner's chosen event, the winner will be asked to choose another event. Once two complimentary tickets for a winner's chosen event have been issued, they cannot be changed and Vector will send the tickets to the winner by email ('e-tickets').
 - 7. The winner of each Monthly Prize Draw will be drawn from all eligible entries for the relevant month, and the winner of each Monthly Prize Draw will be notified by 5th day of the following month. Vector's decision is final and no correspondence will be entered into in relation to it. No late entries will be accepted.
 - 8. The winner of each Monthly Prize Draw will be notified by Vector by mobile phone or email. If a winner cannot be contacted for any reason within 5 days, or is unwilling or unable to accept the Prize, the Prize will be forfeited and another winner will be drawn.
 - 9. Employees of Vector and its related companies or members of the employee's families (including siblings, spouses, grandparents, parents, children, and grandchildren whether by marriage, past marriages, remarriage, adoption, co-habitation or other family extension) are not eligible to enter the Monthly Prize Draw.
 - 10. Neither Vector nor any other person or party associated with the Prize shall be liable for any loss or damage whatsoever suffered (including, but not limited to, indirect or consequential loss) or personal injury suffered or sustained in connection with the Prize offered.
 - 11. Each winner is responsible for all other expenses including, but not limited to, spending money, meals, drinks, transport, accommodation and incidentals.
 - 12. Vector reserves the right to vary, suspend or terminate the Monthly Prize Draw at any time.
 - 13. Vector reserves the right to refuse to award a Prize where there is a breach of any of these terms and conditions or where Vector considers (in its sole discretion) that an entrant has gained unfair advantage in participating in the Monthly Prize Draw or won using fraudulent means

In the event that the Prize becomes unavailable for any reason, such as if the event for which two tickets have been issued is cancelled, Vector may substitute the Prize for another prize of like or equal value.
